A Review of Animated Opal Creek Screensaver 1.0 September 21, 2001 By Brian Noon

As I write this review, today is the first day of Autumn, 2001. In addition to the gloomy events of last week, we also now have the Fall (lovely to some, but a precursor of winter to others) to contend with. Can your computer prolong the beauty and peacefulness of a summer's day by your favorite stream?

These are the claims of a new screensaver called Animated Opal Creek, which is available from a website called http://www.sensecandy.com. Here is how the author, Heun Shin, describes his product:

"Imagine being in a beautiful forest. You sit in front of a small creek under the cool shade of giant trees. The sound of the water calms your mind, and the fluttering of butterflies whisk your worries away. This is the experience that this screensaver tries to capture. The screensaver features animated, high-resolution scenes of creeks and butterflies (this can be turned off). The scenes are complimented by sounds of flowing water and chirping birds. It's like watching a movie!"

When I think about watching a movie on my computer, I am thinking about DVD quality, and this screensaver is definitely not that. The scenes seem a little jumpy, this in general detracts from the peacefulness that it aims for. As mentioned above, there are adjustments for the number of butterflies that are shown in the screensaver, and the viewer can chose between 0 and 5 butterflies. The "butterflies" are not really what you would expect: they are different colored fluttering blobs of color. Unique, yes, but not butterflies!

The sound quality is much better than the video. Among the sounds that you hear are the gurgling of the stream, and "ambient" bird noises. In the set up in Control Panel, the author cautions that "on slower computers, sound (sic) may not be wonderful. In that case, turn

bird sounds off (or even turn all sounds off)." I did not have any problem with the sounds on my computer.

System requirements to run Opal Creek are minimal: a Pentium 2 processor and 8MB of free disk space. The operating system requirement is Windows 95/98/ME/NT4/2000 with a file size of only 4.91 MB.

The shareware version of Opal Creek has only 2 scenes, but the full version adds 5 more, for a total of 7 scenes. The cost of the full product is \$7.95, however if you want to try this out before shelling out your dough, you can go to their download link, at http://www.sensecandy.com/downloads/aocssw.exe. The author is also donating \$1 from the proceeds to Earth Share. It sure would be nice to know what Earth Share is!

The Lamp Post Number 25 by John Spizzirri January 12, 2002



You may have heard that Microsoft (MS http://www.microsoft.com) has offered to settle the 100+ private citizen class action law suits by offering computers and MS software to 14,000 of the poorest school districts in the country. MS's contribution will be \$1 billion, with half being hardware and half being MS software. Wait a minute, think about it. \$500 million in software?? That half billion in software is valued at retail. That's the same retail price that the DOJ said in its settlement with MS was ok, even though the appellate court ruled that MS used it monopoly position to gouge consumers with high prices. My guess is that the actual cost to MS will be somewhere in the area of less than \$3 million for the software. Figure it out. WinXP Home is \$199 per unit for a box that contains a booklet and a CD. The actual production costs of a box, booklet and CD are slightly over one dollar. Who knows what 'partnership' agreements will bring down the hardware expense to MS. Even if the figures were actual, MS has an estimated \$35 billion in cash. This is little more that a tap on the wrist let alone a slap. Red Hat (http://www.redhat.com) played a little (self-serving) one-ups-manship after the MS announcement. Red Hat offered to provide open-source software to EVERY school district in the United States for free. Red Hat suggested that MS give the full billion in hardware. When questioned, Red Hat stated that regardless of what MS does, its offer still stands. Steve Jobs, CEO of Apple, said that MS should give the billion dollars to the school districts in cash, so they could decide what to spend the money on. MS, you may remember, bailed out Jobs last year to the tune of \$150 million. Jobs is also self serving, hoping the districts will spend on Apple equipment. Frederick Motz blocked this out of court settlement forcing the issue back into the courts. The way the courts have been ruling in MS cases of late, this may be a major benefit to MS. Just a note on typing in long URL's (Uniform Resource Locators). Anything after the slash after the .com, .gov, .edu, .net, .biz, or .mil must be typed EXACTLY as shown including upper case.

A little over 2 years ago I mentioned eEye Digital Security Company (http://www.eeye.com/html) in this column. That company exposed a security hole in a MS product. MS was outraged and blasted the company in the press (taking the heat off themselves in the process). eEye did it again in late December 2001 exposing the Universal Plug and Play (UPNP) security hole in Windows XP, ME and 98. This time MS was not upset because eEye found this hole in October, told MS about, and waited until MS had a patch before it announced the hole to the world. For about 6 weeks crackers using this security hole could remotely take total control of any computer connected to the Internet and running one of these products to do what ever they wanted, having supervisory access. Remember that XP is also a server product that handles Internet activity like email and Web pages. eEye demonstrated what could be done by taking control of an Associated Press employee's laptop and directing it to access the National Security Agency's Web site (http://www.nsa.gov/). The laptop was on a desk in AP offices in New York while the eEye offices are in California. I would highly recommend that you get the MS patch at

http://www.microsoft.com/technet/security/bulletin/MS01-059.asp or disable UPNP on your system. Disabling UPNP is similar on each version of Windows but not exactly the same. I will

describe the process for Windows ME. Click Start, Settings, Control Panel, Add/Remove Programs. Click Windows Setup TAB. In the Components box click Communications. Click the Details button. Scroll down the list until you come to Universal Plug and Play. If it is checked, uncheck it, click Okay, click Okay again and reboot. If it is not checked, click Cancel twice. The process to do this in Win 98 or Win XP requires that you get to the Windows Setup area and uncheck the UPNP box. Getting there is just a little different in each version. The Infoworld article is at http://www.infoworld.com/articles/hn/xml/01/12/20/011220hnmspatch.xml. Paul Thurrott, of WinNetMag, says that this problem has been overblown in the press and he will prove it in an upcoming article. Read the next paragraph to see what else he has had to say.

Paul Thurrott, a notorious MS supporter and Linux/Apple basher, admitted "The term Microsoft security is a joke of sorts in many circles, an oxymoron that geeks can knowingly nod their heads over and laugh about." He was reflecting about this past year and MS's response to security and privacy problems in virtually every product they produce. Since I have started this article in the beginning of December 2001, there have been at least 3 more detected and admitted security problems with MS software. This does not count the rumor that al-Queda operatives got jobs at MS to purposefully put bugs in the XP products, a rumor BTW I do not believe. The XP Professional Edition Step-Up product is MS's additional way to extract money from you. If you purchase a new PC with XP Home pre-installed before February 28, 2002, you can get a \$75 rebate on the purchase of XP Professional Edition, either by coupon or directly from the manufacturer. Wow, that means you can get XP Pro for \$224, after you have already paid for the home edition. Some deal.

If you are thinking of getting Windows XP, check the Windows SuperSite by Paul Thurrott. He has an article called Windows XP The Good, The Bad, and The Ugly. The article is, surprisingly, honest. Find it at http://www.winsupersite.com.

I am constantly getting pop up and pop under advertisements as well as email come ons. Occasionally, some pique my interest. But how can you tell if they are real or a scam. If you want to check an offer, drop by the Federal Trade Commission (http://www.ftc.gov) or the Better Business Bureau (http://www.bbb.org/library/internetbus.asp).

I recently came across a site that is an eye opener. Crime.com (http://www.crime.com/) has statistics on crime by state, county and zip code. Click on crime stats to check out where you live. You may not feel as safe as you once did.

After checking Crime.com you may want to read the Bible. You can get your own cyber copy at http://members.tripod.com/proagency/freebible.html for free. It is a 12.2MB download (about 35 minutes at 56kbps). It is the King James Version. If you wish to read on line, you can see the New English Translation at http://www.bible.org/ and then click on Net Bible. If you want to read the Koran (Qur'an) on line, you can at http://etext.lib.virginia.edu/koran.html (an English translation).

Lindows sued by MS for unfair business practice? Lindows is a Linux distribution that can natively run Windows applications. MS claims that consumers may think that there is a business agreement between the two companies because of the name similarity. You can get a small article about the suit at http://www.theregister.co.uk/content/4/23484.html .

I had a problem with a relatively new WindowME machine. It became very sluggish, Defrag would stop responding and it would not shut down. What caused the problem is still a mystery but here is the solution. By the way (BTW) most of this stuff works on Win98. Do these steps in this order for best results. (The APC Powerchute Plus program will cause Defrag to hang.)

- -First scan ALL files for a virus using a compatible virus checker. If a virus is found, clean it. Restart the computer to see if that solves the problem.
- -Check the bootlog.prv and the bootlog.txt files for errors. These are hidden files in the root directory of the C:\ drive. To unhide them run Windows Explorer. Select Tools from the menu, Folder Options on the pulldown, View tab then select Show hidden files and folders then click ok. Double click on bootlog.prv (use Notepad to view it) and search for the word Fail. If the word is found, read the lines where it is found for a clue as to the problem. Do the same to the bootlog.txt file. Usually, the line will indicate a software load failure. Find the file and reinstall it.
- -Disable the Windows Exit sound. Click Start Settings Control Panel (if necessary, View all Control Panel options) Sounds and Multimedia properties Exit Windows in the name pull down box select (none). Restart the computer. If it solved the problem, the sound file you were using is corrupted. Replace it from the Windows installation CD.
- -Check the Startup folder at C:\WINDOWS\Start Menu\Programs\StartUp. Remove or move all programs or shortcuts there. Restart the computer to see if that solves the problem. If it solves the problem, add one program or shortcut back in the Startup folder at a time restarting the computer after each to see which one is the culprit. BTW if Find Fast is in the Startup folder do NOT add it back it uses too many system resources.
- -Run MSConfig selecting standard VGA. Click Start Run type in msconfig click ok. Select the advanced button and check the VGA 640x480x16 box. Restart you machine. If this solves the problem, you need a new video driver.
- -Run MSConfig selective startup. Click Start Run type in msconfig click ok. Undo what

you did in the previous step. Select Selective Startup and un-select Process System.ini file and Process Win.ini file. Click ok and restart your machine. If that solves you problem, repeat this step un-selecting only the System.ini. Restart your machine. If that solves the problem, then something inside the system.ini file is causing the problem. If not, rerun MSConfig un-selecting only the Win.ini file. If that solves the problem, something inside the Win.ini file is causing the problem. If you have problems in either of these files, check the MS knowledge base on the Web at http://www.microsoft.comforadvice.

-Check all hardware profiles to make sure all are working correctly. Click Start - Settings - Control Panel - (if necessary, View all Control Panel options) - (double click) System icon - Device Manager tab. Any devices that are not working correctly will have a red or yellow icon in front of them. If any device has the red or yellow icon in front of it, check that device to see what the problem is and restart the computer. If all are working correctly, try disabling the network card if you have one. Restart the computer. If that did not solve the problem or you do not have a network card, try disabling the sound card. Restart the computer. If either of these solves the problem, you need a new driver for the device.

-Another factor may be corrupt files, folders, or bad sectors on your hard disk. To correct this the first thing you need is a Windows startup disk. You should already have one, but if you don't here is how to create one. You'll need a formatted floppy. Click Start - Settings - Control Panel - (if necessary, View all Control Panel options) - Add/Remove Program Properties - Startup Disk tab. Insert the disk and click Create disk. Next you'll need to run Disk Cleanup. Click Start - Programs - Accessories - System Tools - Disk Cleanup - select the c: drive. Disk Cleanup will have pre-selected files to delete, click ok to delete them. Shutdown the machine. Start up the machine using the startup disk. Configure ScanDisk to detect disk timeouts and check each cluster five times in the Scandisk.ini file. Find the file in the c:\Windows\command folder. Edit the file using Edit. In the [Environment] section in the file edit or create these two lines.

ScanTimeOut=On

NumPasses=5

If the section does not exist, create an [Environment] section with the above two lines below it. The ScanTimeOut= and NumPasses= lines may already exist, but with different values, if they do, change the existing values to On and 5, respectively. Exit Edit. Start Scandisk by typing its name. Make certain it is operating on the C:\ drive. Depending on the size of your drive, the time required for the surface scan may be upwards of 2 hours. Although Scandisk reported that there were no errors on my drive, my machine was cured of sluggishness and Defrag worked perfectly after a reboot.
